Motor Vehicle Policy

Students who drive on campus are expected to have:

1. A copy of a valid driver's license on file in the office.
2. A copy of a current insurance card on the vehicle they are driving.
3. A parking sticker displayed on the left front windshield.

The Student Agrees:

1. to properly park only in the designated areas for students and their assigned parking space at all times.
2. to drive in a responsible manner so as not to endanger lives or draw undue attention to themselves and/or their vehicles by noise or reckless driving, speeding, etc.
3. not to sit in or on vehicles or litter in the parking lot during school hours. (Including lunch time)
4. to any state laws relative to motorcycles (helmet, mufflers, etc.) apply on campus.
5. adhere to the posted speed limit signs on FLA property and obey the driving laws of the state of Florida.
6. to not leave campus or transport any other students during school hours without approval.
7. to be responsible for all materials in his/her vehicle. To be responsible for everything that happens in his/her vehicle.
8. to authorize school personnel to conduct a warrantless search of the vehicle if there is a reasonable suspicion.
9. to have the police involved if there are any accidents in the parking lot or on the campus involving your vehicle.
10. agrees not to take anyone in their vehicle without written permission.
